

## Pay Your Taxes Electronically

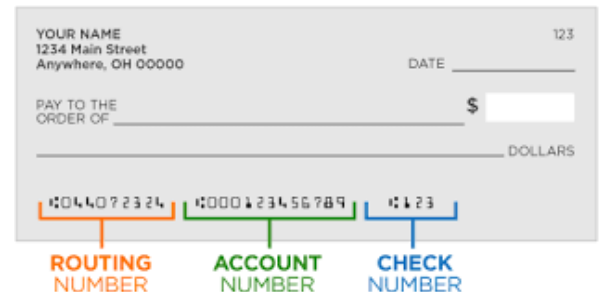
Due to the continued backlog at all government taxation levels, we strongly recommend that all taxes (i.e., Extensions, Estimates, Individual Federal, State, and Local) be made electronically.

## PA Tax Payments

Payments for personal income tax payments equal to or greater than \$15,000 must be made electronically. Payments not made electronically will be subject to a penalty equaling 3 percent of the payment amount, not to exceed \$500.

## IRS 1040 Payments

Multiple payment options include bank debit, wire transfer, and credit card. It is crucial to verify you have entered all of your banking information accurately on these websites. Incorrectly entering your bank information will prevent your payment from being processed and may result in tax penalties. You can use the image to the right as a reference for how most checks show the routing number and account number.



**Make sure all payments are made under the social security number listed for the Primary Taxpayer on Form 1040.**
